



WAIVER AND RELEASE OF LIABILITY

This Waiver and Release of Liability is a legal document, and all of its terms are important. PLEASE READ IT CAREFULLY.

My signature below acknowledges my understanding that there is a risk that I (and, if I am the legal parent/guardian of a Missouri Boys State participant, the Missouri Boys State participant) ("MBS Participant") to be exposed to COVID-19 as a result of my (or my MBS Participant's) entry to Missouri Boys State ("MBS") at the University of Central Missouri ("UCM") in Warrensburg, Missouri and participation in any activities in any way connected with UCM or MBS (the "Activities"), and my agreement to release MBS from liability in the event I (or my MBS Participant) am/is exposed to the coronavirus as a result of my (or my MBS Participant's) participation in any Activities.

ACKNOWLEDGMENTS:

On behalf of myself and my (or my MBS Participant's) heirs, assigns, personal representatives and estates, I acknowledge and agree that despite MBS having implemented reasonable preventative measures, the program cannot guarantee that I (or my MBS Participant) or any Missouri Boys State participant, MBS staff member, or UCM personnel will not become infected with COVID-19, and there are risks inherent in entering the UCM campus and participating in the Activities and inherent risks related to COVID-19 infection and transmission.

ASSUMPTION OF RISK:

I (for myself, or on behalf of my MBS Participant) hereby acknowledge and agree that I (or my MBS Participant) may be exposed to the coronavirus because of participation in the Activities. I (for myself, or on behalf of my MBS Participant) hereby assume all risk, dangers (including personal injury, illness, disability and death), and responsibility for any losses or damages, whether caused in whole or in part by the acts or omissions of MBS, its employees, volunteers, officers, directors, or any other person or entity acting in any capacity on its behalf (collectively referred to herein as the "Releasees"), that may arise. I (for myself, or on behalf of my MBS Participant) understand that I am releasing, discharging, and waiving any claims or actions that I (or my MBS Participant) may have presently or in the future have for the negligent act or other conduct of the Releasees.

RELEASE:

I (for myself, or on behalf of my MBS Participant) am giving this Waiver and Release of Liability to the Releasees. I agree that my (or my MBS Participant's) entering UCM and participation in any Activities is in all respects voluntary. In consideration of MBS permitting me (or my MBS Participant) to enter into UCM and to participate in the Activities, I (for myself, or on behalf of my MBS Participant) hereby voluntarily release, discharge, hold harmless, and covenant not to sue the Releasees on behalf of myself (or my MBS Participant) for any and all claims or liabilities arising out of any negligence, fault, breach of contract, or any other act or omission which is in any way related to COVID-19 or any claim for illness, injury, disability, death, emotional injury, or damages of any nature in any kind in connection with my (or my MBS Participant's) entering into UCM or participation in the Activities or otherwise related to COVID-19. I understand that my agreement binds me and my (or my MBS Participant's) heirs, assigns, and estates.

I agree that if any portion of this Waiver and Release of Liability is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
